

Photo Competition Terms & Conditions 2017

1. Instructions on how to enter and the prize information forms part of these Terms and Conditions of entry. Participation in this Competition is deemed as acceptance of these Terms and Conditions of entry.
2. The Competition commences at 9:00am Australian Eastern Standard Time (AEST) on Friday 9 June 2017 and concludes at 5:00pm (AEST) on Sunday 6 August 2017 (Promotional Period).

12. The judging panel will review all entries submitted. The 3 entries that are judged to be the best will be deemed the prize winners.
13. The winners will be notified by social media announcement, only. it is the responsibility of the winners to contact the promoter to arrange collection of their prize(s) from Barzura at 62 Carr Street, Coogee 2034.
14. Officers, employees and immediate families of officers and employees of the Promoter, the Sponsor and the associated companies and contractors of the Promoter and any other agencies associated with this Competition are ineligible to enter. (Please note this means that staff cannot enter).

 - 15.1. Entrants will be responsible for all costs associated with entering the Competition, including but not limited to costs associated with accessing the internet.

An entry that is incomplete, indecipherable, illegible or non-compliant with these Terms and Conditions is invalid and will not be accepted or considered. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If this Competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to modify, suspend, terminate or cancel the Competition to the full extent permitted by law and subject to any approval or directions from a regulatory authority.
18. The Promoter's decision is final and no other correspondence will be entered into.
19. In consideration for the Promoter awarding the prize to the winners, the winners hereby assigns to the Promoter all right, title and interest in and to all copyright in any material created pursuant to the winner's participation in any aspect of the prize (Works). The winners give the Promoter the authority to edit the Works in accordance to the requirements for printing for display at Barzura.

The winners acknowledge that the Promoter is free to use the Works and to exercise its rights in relation thereto and the winners will not be entitled to any fee for such use. The printed winning Works will be credited on Barzura's website www.barzura.com.au and in Barzura Café Restaurant Bar with labels featuring the title and crediting you for the work.

20. Barzura can sell the unframed Works on your behalf during the Work's 12-month placement at Barzura. The unframed Work will be available for collection by the Buyer post the 12-month display period. Barzura requests that 20% of the sale go towards charity in exchange for Barzura's printing costs of the Work, the remaining 80% will go directly to the photographer of the Works. Barzura will contact photographer of the Works directly if a sale is made.
21. If the Work is not sold during the 12-month period, Barzura will contact the photographer of the Works to collect the unframed printed Work from Barzura post the 12-month period.
22. It is a condition of entry that the entrant consents to the Promoter using the entrant's name, likeness, image and/or voice in the event they are a winner of a Prize (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of the Competition (including any outcome), and promoting any products and services, distributed and/or supplied by the Promoters.
